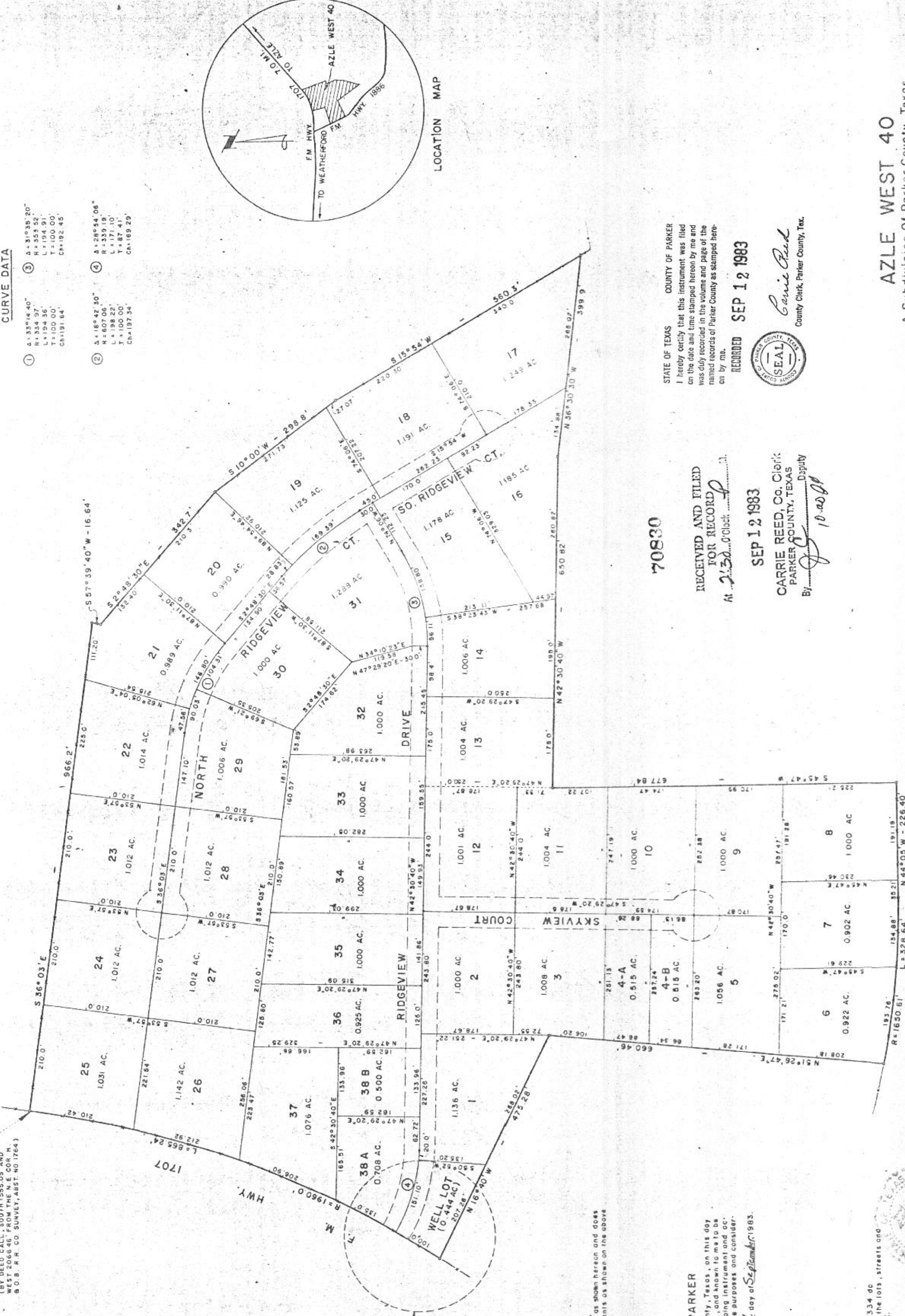


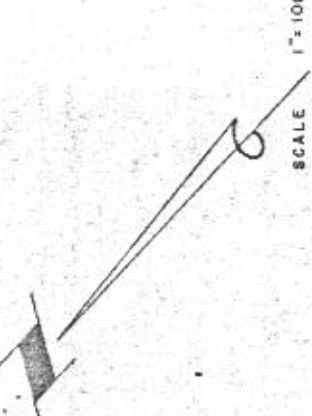
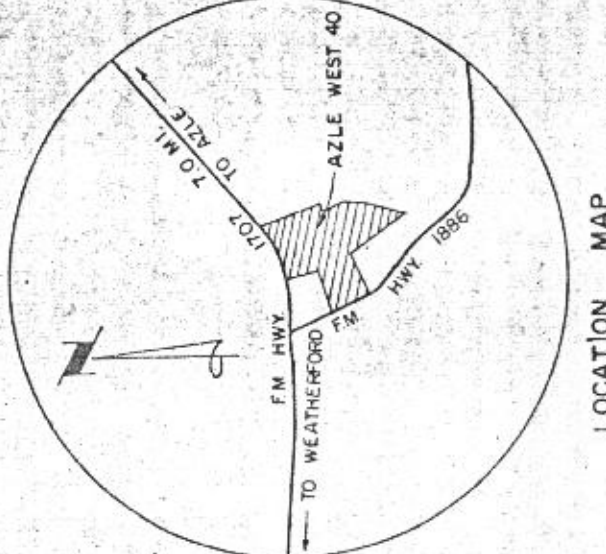

The GC roads are not maintained by the county.

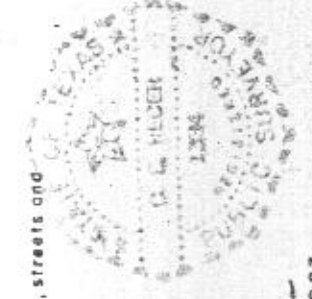
