FIELD NOTES

FIELD NOTES of a 1.62 Acre tract of land, being a part of the S. Monk Survey, Abstract 906 and the E. Crockett Survey, Abstract 214, Parker County, Texas and being more fully described by metes and bounds as follows:
 BEGINNING at a steel rod in the EBL of N. Bankhead Road (Mesa St.), said point being N 89 deg. 24 min. 20 sec. W., 20.68 ft. from the S.W. Corner of the E. Crockett Survey, Abstract 214;
 THENCE S 89 deg. 24 min. 20 sec. E., 125.52 ft. to a steel rod for a corner;
 THENCE N 00 deg. 26 min. 10 sec. E., 550.38 ft. to a steel rod in the SBL of U.S. Hwy No. 80, for a corner;
 THENCE, with the SBL of the above mentioned U.S. Hwy No. 80 and with a Curve to the Right, said Curve having the following data: Radius 5810.69 ft.; Chord N 87 deg. 29 min. 47 sec. W., 129.82 ft. a distance of 129.83 ft. to a steel rod for a corner at the point of intersection of the SBL of said U.S. Hwy No. 80 with the EBL of above said N. Bankhead Road (Mesa St.);
 THENCE, with the EBL of said N. Bankhead Road (Mesa St.) SOUTH, 554.73 ft. to the place of beginning and containing 1.62 Acres of land, more or less.

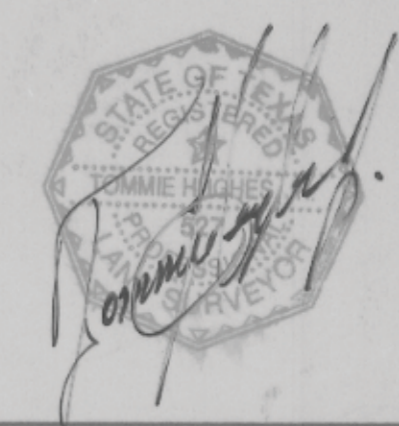

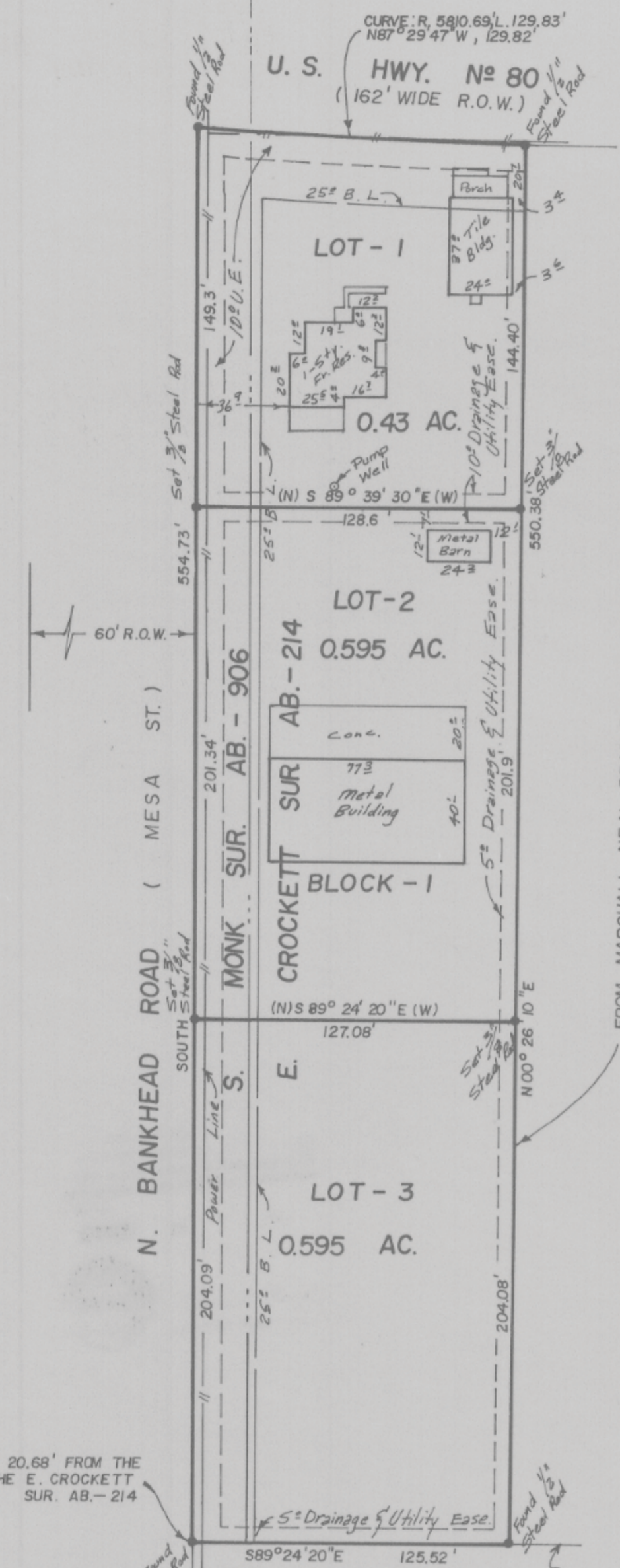
