IN WITNESS THEREOF THIS DEDICATION IS EXECUTED.

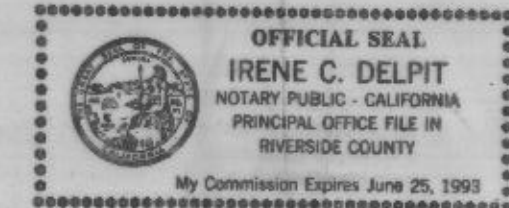

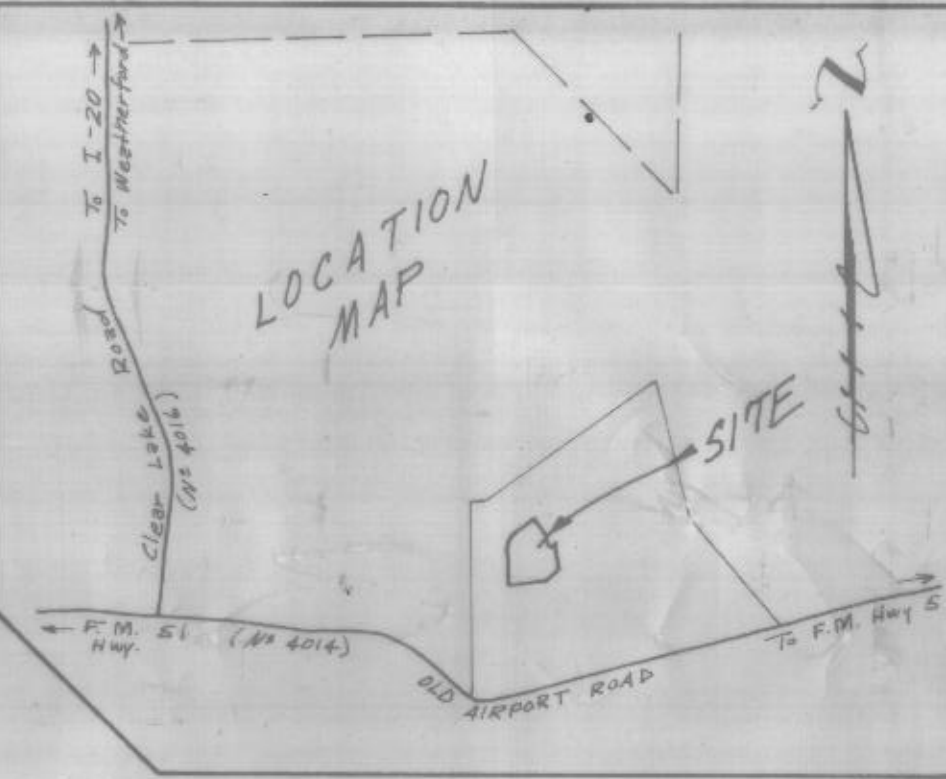
