 THENCE North 1040 ft. to a steel rod for a corner in the SBL of a County Road;
 THENCE, with the SBL of the above mentioned County Road, the following calls: N 86 deg. 35 min. 11 sec. E, 253.05 ft.; N 87 deg. 30 min. 48 sec. E, 582.27 ft.; N 84 deg. 17 min. 49 sec. E, 600 ft. to a steel rod for a corner;
