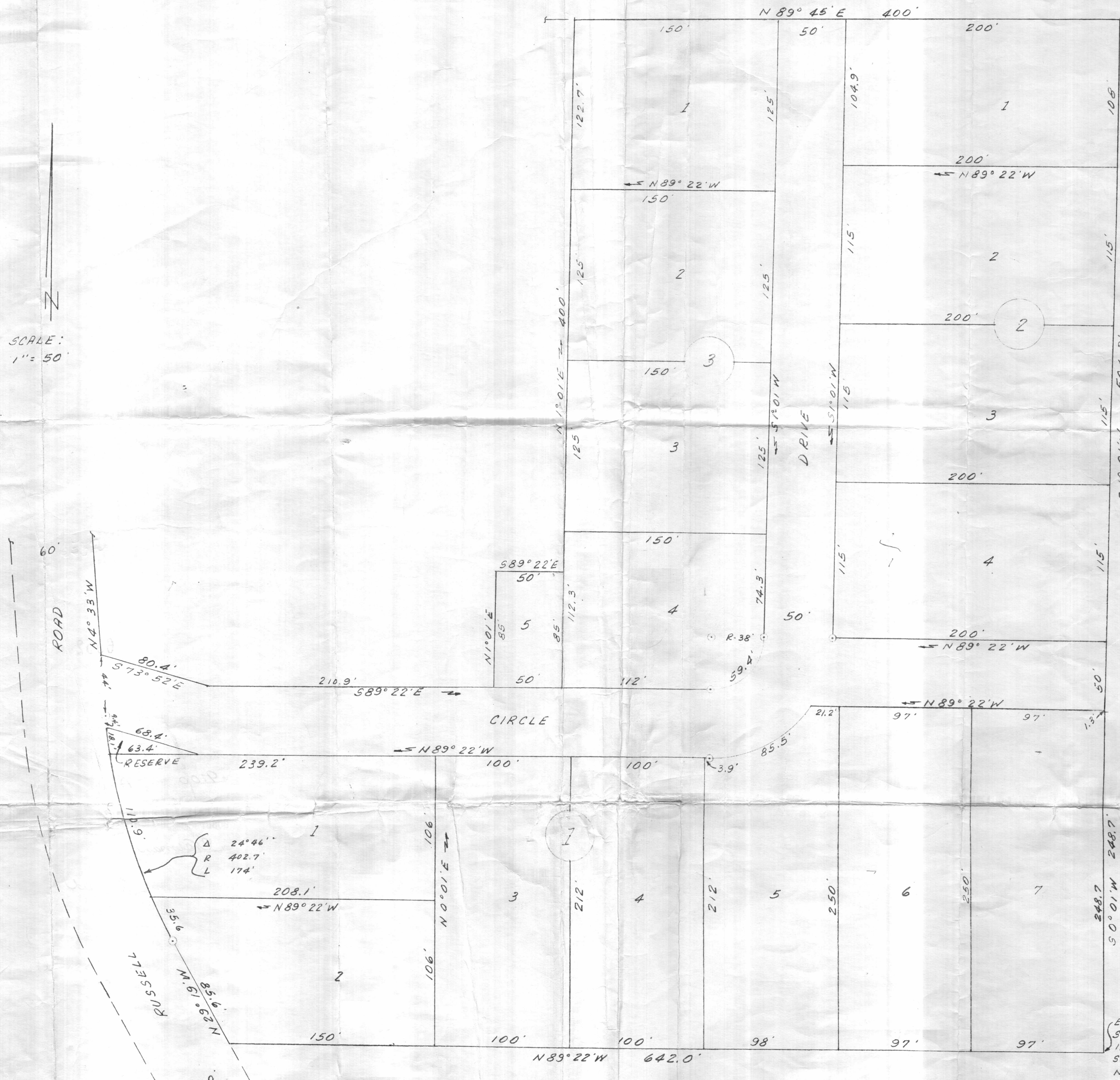


PLAT
