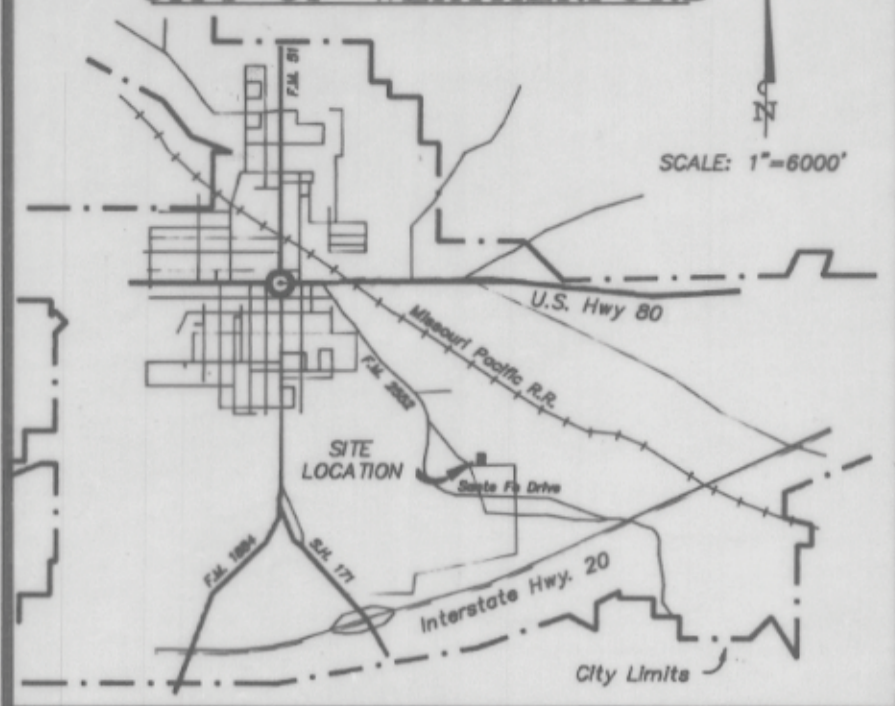


CITY OF WEATHERFORD

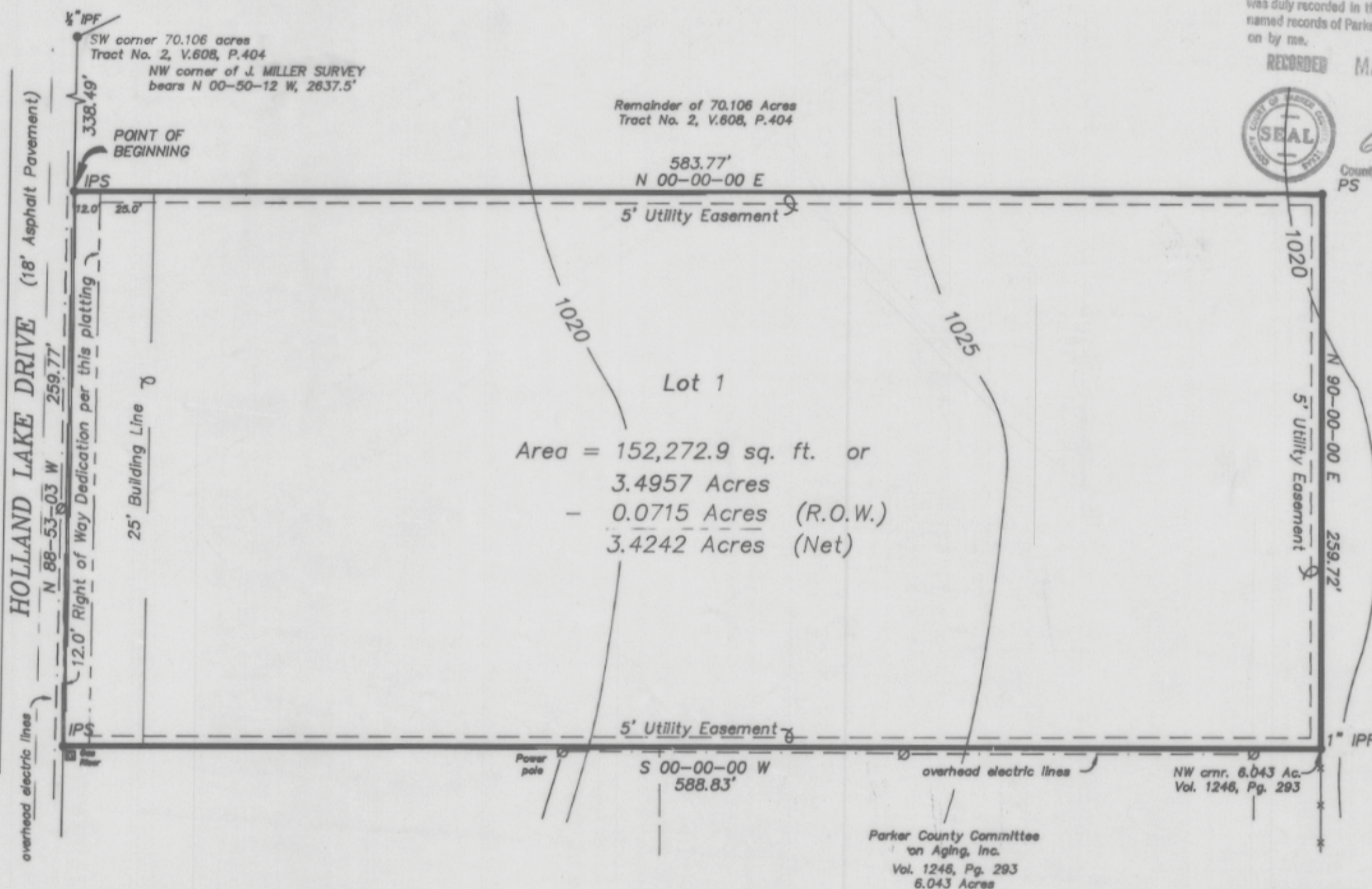

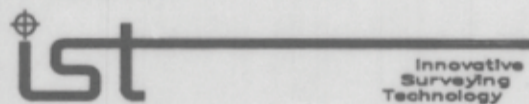

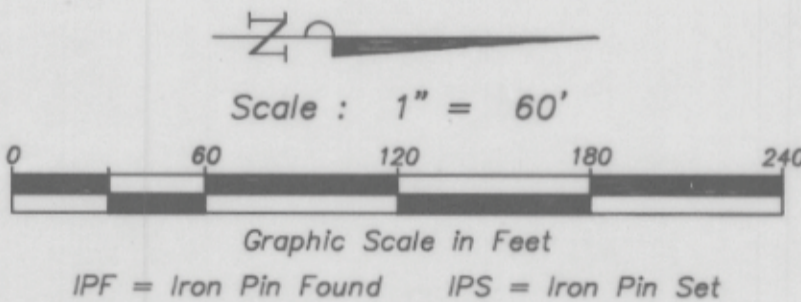

DEDICATION

WHEREAS I, O. L. PITTS, being the duly authorized representative of HOLLAND LAKE PLACE, Inc., owners of that certain tract or parcel of and situated in the JOHN E. MILLER SURVEY, Abstract No. 890, in the City of Weatherford, Parker County, Texas, and being 3.4957 acres of land out of that 70.106 acre tract of land described as Tract No. 2 in deed from Elmer Woodriddle to O. V. DiSciullo dated May 20, 1975 and recorded in Volume 608, Page 404 of the Deed Records of Parker County, Texas, and being more particularly described by metes and bounds as follows:

BEGINNING at a 1/2 inch iron pin set in the north line of Holland Lake Drive, said point bearing South 88 degrees 53 minutes 03 seconds East, 338.49 feet from a 1/2 inch iron pin found for the southwest corner of the aforementioned 70.106 acre tract; and said point being the southwest corner of the tract described herein;

THENCE North 00 degrees 00 minutes 00 seconds East, a distance of 583.77 feet to a 1/2 inch iron pin set for the northwest corner of the tract described herein;

THENCE North 90 degrees 00 minutes 00 seconds East, a distance of 259.72 feet to a 1 inch iron pin found, said point being the northwest corner of a 6.043 acre tract conveyed to Parker County Committee on Aging, Inc., recorded in Volume 1246, Page 293, and the northeast corner of the tract described herein;

THENCE South 00 degrees 00 minutes 00 seconds West, along the west line of said 6.043 acre tract, at 310 feet pass the westerly southwest corner of said 6.043 acre tract, in all a distance of 588.83 feet to a 1/2 inch iron pin set in the north line of Holland Lake Drive;

THENCE North 88 degrees 53 minutes 03 seconds West, along the north line of said Holland Lake Drive, a distance of 259.77 feet to the POINT OF BEGINNING and containing 152,272.9 square feet of land or 3.4957 acres, more or less;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

That I, O. L. PITTS, do hereby adopt this plat as Lot 1, HOLLAND LAKE PLACE, an Addition to the City of Weatherford, Parker County, Texas, and do hereby dedicate to the public use forever the easements and Right-of-Way as shown hereon.

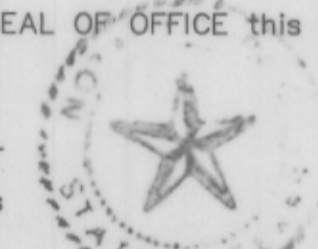
