

STATE OF TEXAS COUNTY OF PARKER

WHEREAS, Jeanine Lindsey and Gina Lindsey Carpenter being the owners of Lots 15, 16 & 17, SOUTHWOOD MANOR, an Addition to Parker County, Texas, according to the plat thereof recorded in Plat Cabinet B, Slide 194, P.R.P.C.T., and being the same tracts of land recorded in Vol. 1697, Pg. 1298, R.R.P.C.T.

Description for a 3.96 acre tract of land out of the Q.N. ANDERSON SURVEY, Abstract No. 1, Parker County, Texas, said tract being all of Lots 15, 16 & 17, SOUTHWOOD MANOR, an Addition to Parker County, Texas, according to the plat thereof recorded in Plat Cabinet B, Slide 194, P.R.P.C.T., and being the same tract of land recorded in Vol. 1697, Pg. 1296, R.R.P.C.T.

BEGINNING at a capped iron found in the North line of Lynch Bend Road, said iron being for the Southwest corner of said Lot 17, and for the Southeast corner of Lot 18;

THENCE N 00°57'58" E, with the common line of said Lots 17 and 18, 344.59 feet to a capped iron found, said iron being for the Northwest corner of said Lot 17, the Northeast corner of said Lot 18, the Southeast corner of Lot 14, and the most Westerly corner of said Lot 16;

THENCE N 33°32'19" E. with the Southeasterly line of said Lot 14, and with the Northwesterly line of said Lots 16 and 15, 280.18 feet to a capped iron found in the Southwesterly line of Southwood Bend, said iron being for the Northwest corner of said Lot 15, and for the Northeast corner of said Lot 14:

THENCE S 56°27'41" E, with the Northerly line of said Lot 15, and with the Southwesterly line of said Southwood Bend, 350.00 feet to a 1/2" capped iron set;

THENCE S 10°55'23" E, 28.61 feet to a 1/2" capped iron set, said iron being at the intersection of the Southerly line of said Southwood Bend, and the West line of F.M. Highway No. 51;

THENCE S 33°31'44" W. with the East line of said Lots 15, 16 & 17, and with the West line of said F.M. Highway No. 51, 426.35 feet to a capped iron found, said iron being for the Southeast corner of said Lot 17, and being at the intersection of the West line of said F.M. Highway No. 51, and the North line of said Lynch Bend Road;

THENCE S 89"41'23" W, with the South line of said Lot 17, and the North line of said Lynch Bend Road, 222.27 feet to the POINT OF REGINNING and containing 3.96 acres of land.
