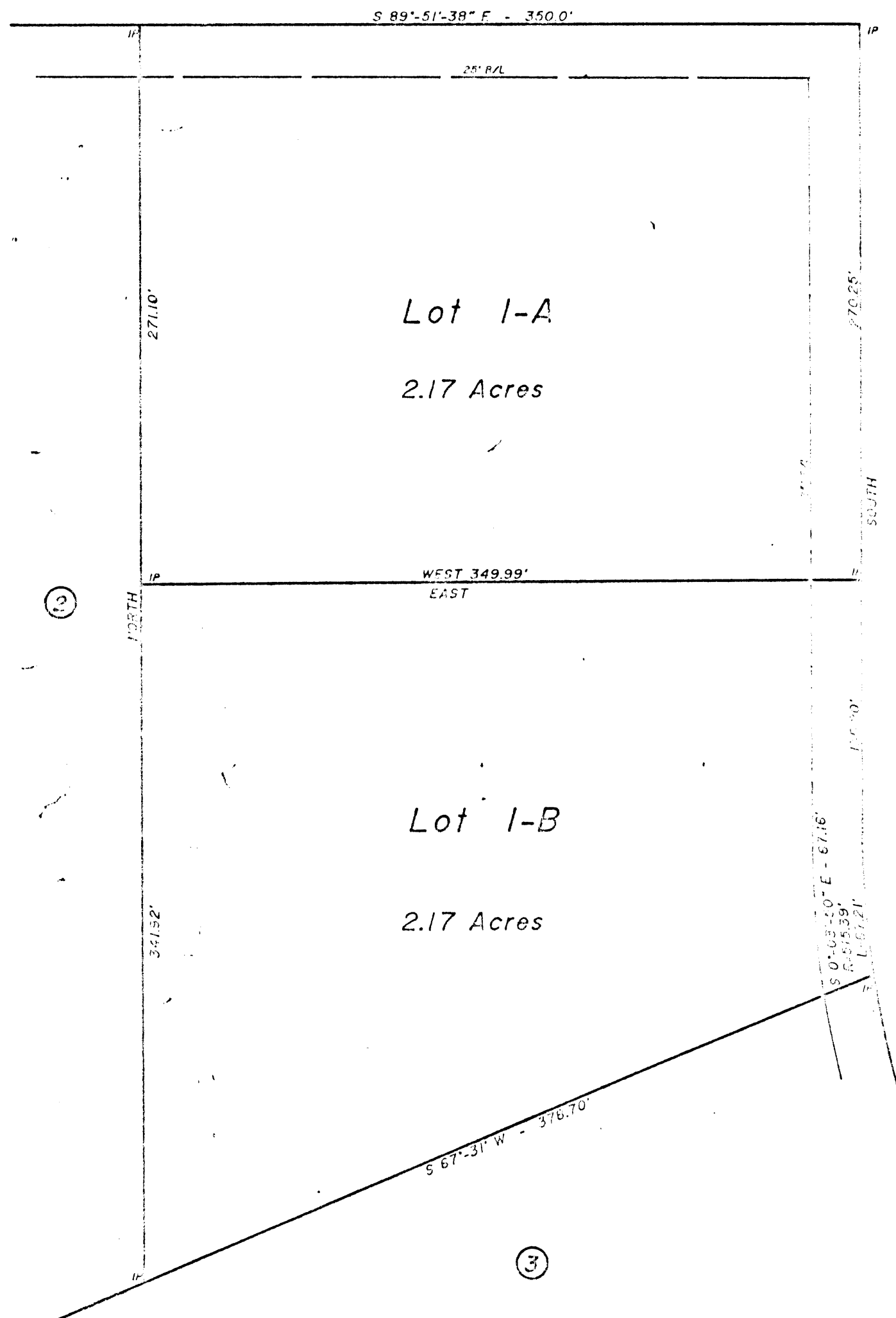
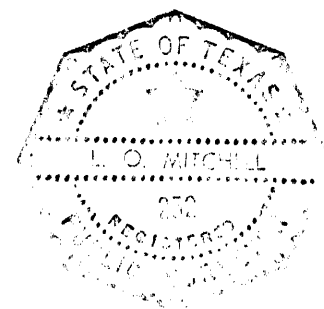


WHITE SETTLEMENT ROAD
