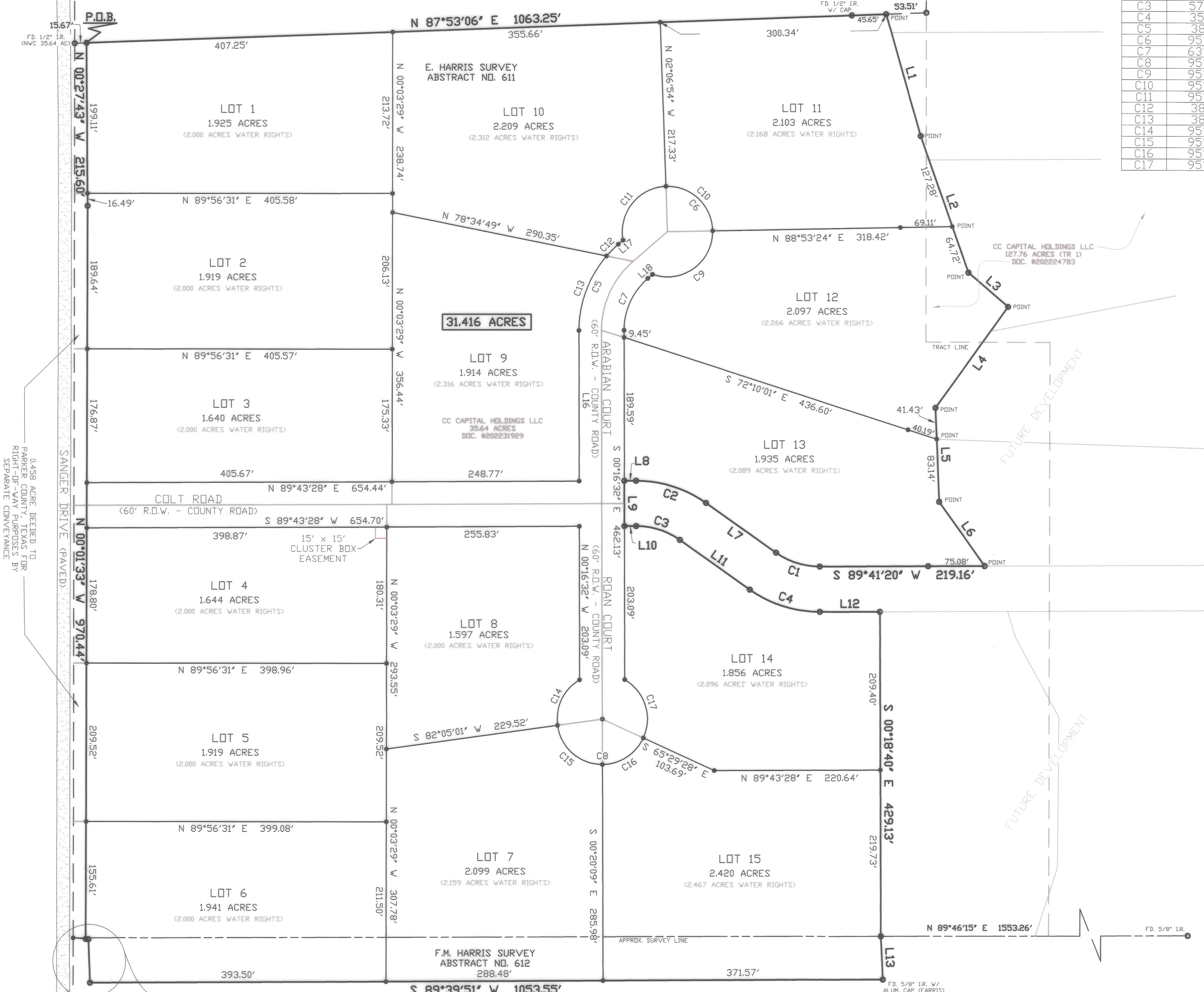

PLUGGED WITHIN NINETY (90) DAYS OF SUCH TRANSFER.



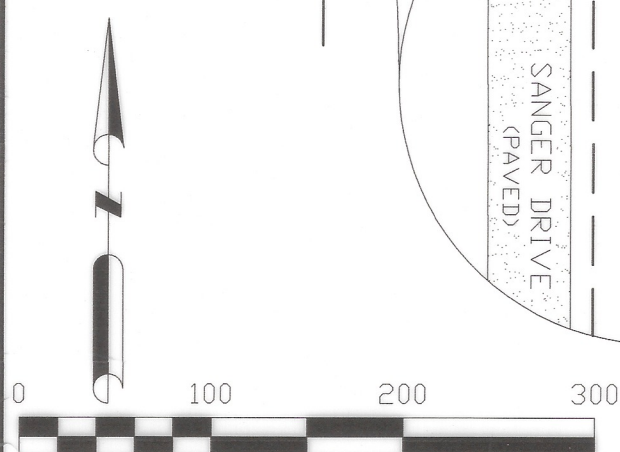

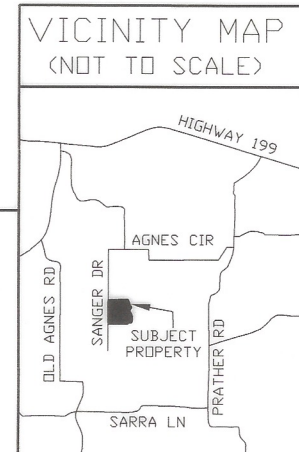

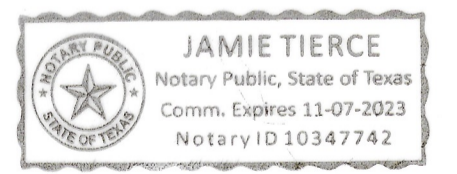
