 - THENCE S 89° 45' E 625.96 to a point for a corner in the West line of F.M. No. 730;
 - THENCE S 0° 38' E with the West line of F.M. 730 30' to a point for a corner;
 - THENCE N 89° 45' W 44.96 to a point for a corner;
 - THENCE S 0° 38' E 105.8 to a point for a corner;
 - THENCE N 89° 45' W 211.0 to a point for a corner;
 - THENCE S 0° 38' E 309.4 to a point for a corner in the North R.O.V. line of State Hwy No. 199;
