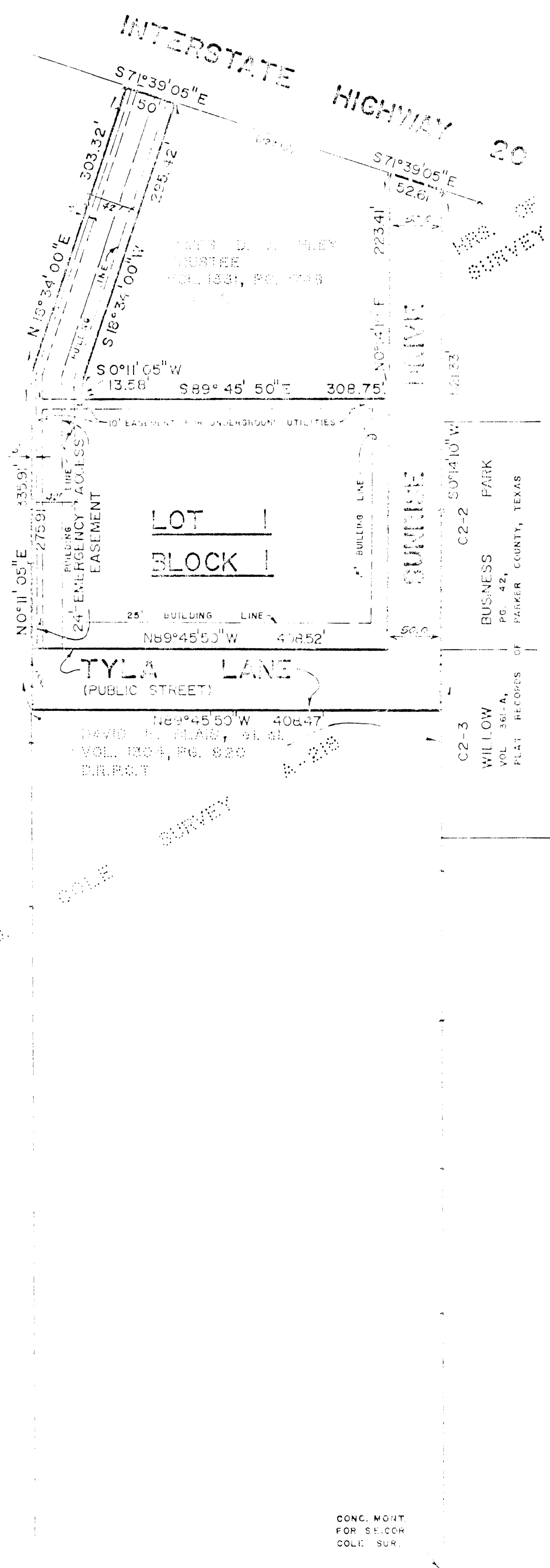
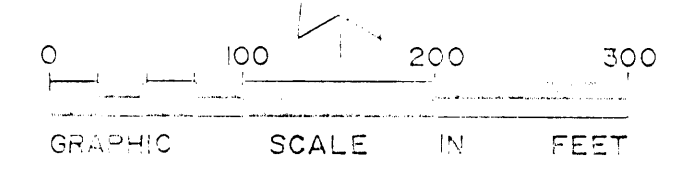
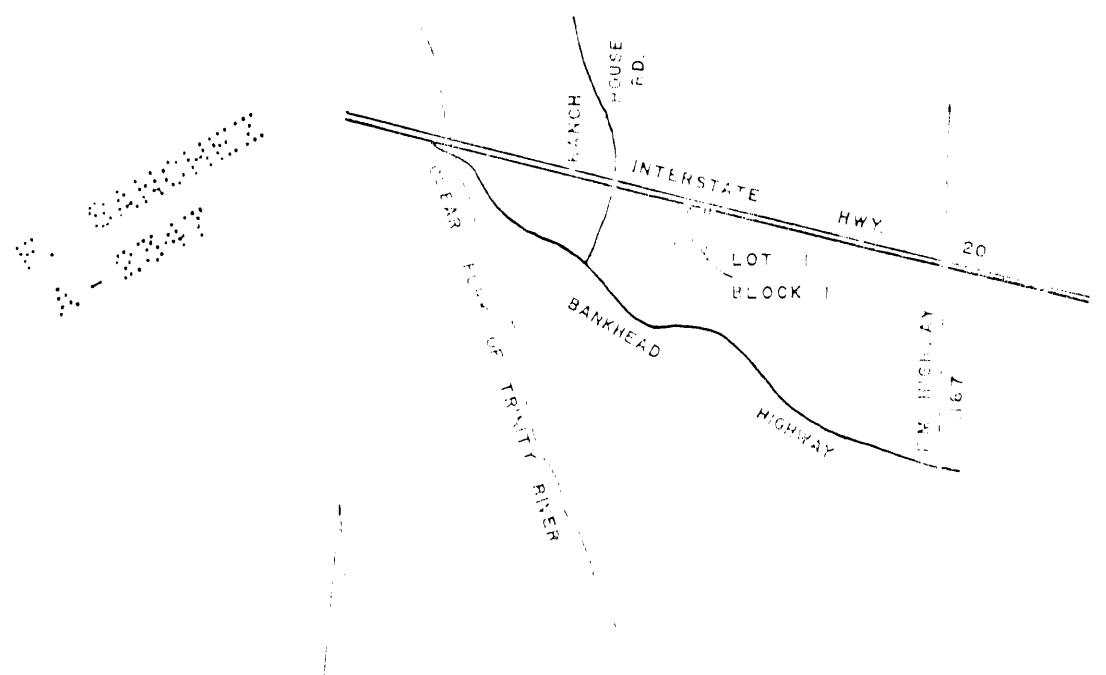

 100 feet to the PLACE OF BEGINNING.

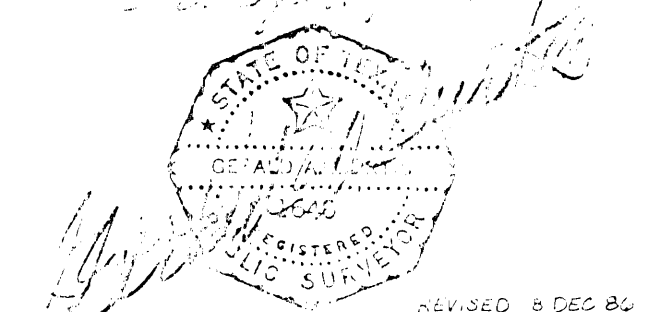
TO HAVE THE PLAT HEREON as shown and set forth for subdivision, said portion of
